
Linda & Frank Carey (Unit #1221)




Bonnie Barry (Unit #1124)



WHEEEEL OF FOOOOR-TUNE

I wonder how many people here at Emerald Court, who at 7:00 pm, Monday through Friday, sit down in front of their TV's to watch the game show, "Wheel of Fortune". I know Linda and I are regular watchers and I'm sure we are not in the minority.

The popularity of this show has endured for decades and the show's host, Pat Sajak and co-host, Vanna White have become TV icons.

I personally think the show's popularity is because "Wheel of Fortune" is a light, viewer friendly TV game show that allows the viewer to play along with the actual contestants.

It would be difficult to try and explain all the rules of the game so I will just say that the game's premise is fairly simple. One by one, co-host, Vanna White exposes the letters each contestant requests as they try to be the first to identify names, places, or phrases, hidden on a word puzzle board.

Most of us, as viewers, can't help but play along, trying to identify the puzzle word(s) before the actual contestants do. I think of it as a simple brain exercise and lots of fun.

But of course we, the viewers, are not on TV competing. We're in our TV room relaxing while probably enjoying a beverage and a snack. NO Pressure.

So, what would it be like to be an actual competitor? How would you feel being on the stage, along with Pat Sajak and Vanna White, trying to win

prizes, while TV cameras are filming you in front of a live audience?

Well, I happened to hear that Emerald Court had such a person, who in 1984 participated on "Wheel of Fortune", just nine years after the show's inception. Her name is Kathy Walsh #79. I

shared that info with Elaine Williams, my article writing partner, and together we convinced Kathy to let us interview her regarding her experience. We also invited Kathy's husband Kevin to join us at our interviews.

It has been 40 years since their Wheel of Fortune experience so it's understandable that Kathy and her husband Kevin had a bit of trouble, recalling exact details of the entire experience. However we hope you'll enjoy the following information we were able to garner from Kathy's participation on "Wheel of Fortune".

In 1984, Kathy and a couple of friends heard or read that the producers of the "Wheel of Fortune" game show were looking for people to audition for a chance to participate on TV in the WOF game show. Thinking it would be fun and exciting to try out with the possibility of going to Los Angeles and being on TV if they were successful, they decided to go to the Colonnade Hotel in Boston where the tryouts would be held.

At the tryouts, Kathy and her two friends were informed that the producers would be selecting ten college students and ten adults from the huge number of people who were there to try out.

The audition was divided into two segments. In the first segment they were given five puzzles printed on sheets that looked like the WOF's puzzle board. Kathy said each puzzle had comas, hyphens, and similar punctuations to help in solving the puzzles, but she couldn't remember if the puzzles had any letters. Everyone had only ten minutes to solve all five puzzles. Kathy solved all five puzzles and was able to move on while her friends were not as fortunate.

The second segment of the tryout had those that passed the first segment brought onto a mock WOF stage where they played a number of WOF games. After playing the games they were told they would receive a letter in the mail, informing them if they were accepted or not.

Kathy had done well and did receive a letter notifying her she had been selected along with the date she would be appearing on the show.

The round trip flight, and the three day stay in Los

Angles for both Kathy and her husband Kevin, were covered by the show.

On the scheduled day they were to leave, Kevin and Kathy brought their two children, Patrick eight, and Kelly four, to Kathy's mother's house where arrangements had been made for them to stay. They then rushed to the airport, flew to Los Angeles, where, upon landing, they were picked up and taken to the NBC studios.

At the studio, Kathy was taken to an area to have her hair and makeup done and then brought to the theater, and placed, along with her husband, in the audience area where the WOF show would take place.

As she and Kevin waited for Kathy's turn to play the game, she remembers breathing a sigh of relief, as it was the first time that day that she was finally able to relax. However, that relaxing time was short lived as it was announced that she would be playing in the first game.

On stage, and behind the rail, contestants had to step up on a platform to get into their positions. Kathy said the reason for the platform was so the contestants could better reach the wheel when they bent over to spin it. Kathy also said the wheel was very heavy and a bit hard to spin.

Players were assigned a colored spot on the platform where they would stand: Red, yellow, or blue. Kathy was assigned the first spot which was red. She remembers being a bit upset because she had worn a beige suit and thought she would look better in front of the blue spot. The yellow was taken by another adult and the blue was assigned to a college student.

Kathy's impression of Pat Sajak was that he was taller than he looked on TV and that he was very nice. She said that like today's show, Pat had cards that he referred to when introducing the contestants.

Vanna, Kathy said, was Vanna; beautiful and smiling. Kathy noticed that when turning the letters, Vanna would walk one way to uncover a letter, stay on that side, then walk in the opposite direction to uncover the next letter called. She would then stay on that side until the next letter was called.

Kathy solved the first puzzle which was "Don't

Cry Over Spilled Milk". When she told Pat she wanted to solve the puzzle, he told her to carefully pronounce the words. She was very nervous and remembered what she was taught by the Catholic nuns at St. Mary's High School in Lawrence: "Stand straight and enunciate your words".

So she stood straight and very slowly, clearly and carefully, said each word of the puzzle. Kathy laughed about it as she told us because she had said it so carefully, Pat Sajak told her "You're taking this game too seriously".

That game was the only one she won. The college student was the big winner, winning the most money.

In 1984, the game awarded prizes equivalent to the amount of money each contestant accumulated while playing the game.

The large assortment of the prizes contestants could choose from, were displayed in an area located next to the contestants. The value of each prize was attached to each article.

After she solved the puzzle, she quickly chose the "Van Cleef & Arpels" string of pearls. She also chose a trip to Puerto Valletta and a few minor prizes using up her cash winnings. Certificates for the prizes were sent to her home by mail.

Kathy has frequently enjoyed wearing the pearls but she and Kevin chose not to take the trip due to the unrest in the area of Puerto Valletta at that time.

Although sometimes stressful, Kathy says she totally enjoyed the whole "Wheel Of Fortune" experience from her audition to her participation on the show. Everyone associated with the game was nice and all the contestants rooted for each other.

Both Kathy and her hubby Kevin wish they could remember more but, like most of us, after 40+ years, recall can sometimes be difficult.

Things have evolved since Kathy's appearance on the show. Pat Sajak retired this year and Ryan Seacrest has taken over as host of the show while Vanna will stay on as co-host.

The following are some general facts about WOF that were published by Tami Tolley, in the *The Palm Beach Post* on February 26, 2019.

More than one million people apply each year to

be a contestant, about 10,000 get an audition, but just 600 make it to the live TV show.

The Wheel weighs a whopping 2,400 pounds.

Vanna never wears the same dress twice — that's nearly 7,000 dresses in her 36-plus years on the show!

Pat tries to wear ties that match Vanna's dresses.

The Wheel platform can change height to make it comfortable for all players to spin.

During commercial breaks, contestants are asked to step down from platform with their back toward the wheel while money amounts and prizes on the wheel are changed. Water breaks and makeup touch up happens at this time.

When playing with a partner, microphones are adjusted for the contestants in each group who are closest to Pat.

While in the studio, you cannot look at, wave or talk to your family/friends before your taping.

Vanna holds a Guinness World Record for the most frequent clapper.
